

JOHN F. KENNEDY LOCKER POLICY CONTRACT

LOCKERS ARE ISSUED ONLY ONCE A YEAR. IF YOU LOSE YOUR LOCKER PRIVLEDGE, **YOU WILL NOT BE ELIGIBLE FOR ANOTHER LOCKER UNTIL THE NEXT ACADEMIC SCHOOL YEAR.**

John F Kennedy High School and LAUSD will not assume responsibility for money, personal property, and books that are left in lockers, damaged, lost or stolen from lockers. Students are required to respect school property at all time.

LOCKER ELIGIBILITY

In order to be eligible for a locker, a student must be:

1. Detention free

2. Debt free

- a. does not owe book(s) or fines to the Library
- b. does not owe textbooks, lab fee, uniforms, Student Store charges, class fees, or any other school fee

LOCKER RULES

1. Students are not allowed in lockers during class time.
2. GLASS CONTAINERS, GLASS ARTICLES, WEAPONS, DRUGS AND ALCOHOL ARE NOT ALLOWED IN LOCKERS AT ANY TIME.
3. DO NOT SHARE LOCKERS OR COMBINATIONS WITH ANYONE.
4. No liquid, food or gum in lockers
5. When not in use, lockers must be kept locked at all times
6. Electronic devices, including but not limited to cell phones, I-Pods, MP3 players, beepers, camera/video equipment, walkman, radio, CD players or electronic games are kept in the locker at the student's risk.
7. If a student damages a locker in any way, they will be charged for the damage.

STUDENTS WHO BREAK THESE RULES ARE SUBJECT TO LOSING THEIR LOCKER PRIVILEGE

If a student incurs a debt(s) or detentions at anytime, the student has one week to clear the debt or make other arrangements to clear the debt(s). If the student does not clear the debt/detentions, then he/she will lose their locker privilege for the rest of the academic school year.

LOCKER SEARCHES

Guidelines for Conducting Random Metal Detector Searches and Searching Other Areas of the School

Locker searches will be done daily and randomly without any prior notification. Anything found in the locker that is against school policy will be confiscated and could result in your *locker privileges being suspended immediately, possibly permanently and may include additional disciplinary actions.*
